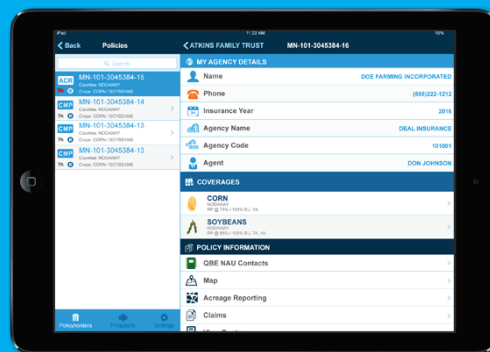
Submission deadline:

EASYmobility To EA\$Ymoney!

If you are first time user, here are some basic steps to get you set up for success with our EASYmobility app.

- Go to the [Apple App Store](#) and search for EASYmobility. Download EASYmobility to your iPad.
- To log in, you will use the same username and password you use to log into our EASYwriter Pro system.
- Your book of business will automatically show up on the left side of the screen.
- Select the producer you intend to key acres in for.
- Select the applicable crop year. The two previous crop years will be available.
- Under the Actions Menu, select “Acreage Reporting”.
- This will provide you with an image of all fields mapped for the selected policy.
- Click any field. You will be able to enter acreage information on the right side of the screen.
- Repeat the process until all applicable fields have acres entered.
- When all acres are keyed, select the “Complete” button.
