

We are just 3 cts/bu away from the highest price for Dec 2019 corn witnessed in all of the past 12 months. Do we really think that once the corn is in the ground these risk premiums will still be here? Even if the market trends or spikes higher later, no problem, because until the RPowerD SCD in April of 2019, RPowerD allows producers to take the most they can out of the market by enabling them to buy-up to a higher RPowerD Minimum Revenue.

Agents have an opportunity right now to help producers Take Less Risk and Make More Revenue for 2019 by showing them how they can use RPowerD to a create a safety net using the only thing in farming that guarantees them money, ie: their crop insurance revenue policies. - 2. Market Price w/ Intervals Select \$0.70/bu of Max Price Movement Limit, Opt-in to Market Price, choose June 2018, July 2018, June 2019, July 2019 Alternative price Discovery Period Intervals.
